## **TELEPHONE INSTRUCTIONS**

**Malfunctions in the telephone sets or system cannot be corrected unless timely notification is made by the person experiencing the problem. Please report all telephone malfunctions by emailing [jeriewhitehead@kanawha.us](mailto:jeriewhitehead@kanawha.us) or dialing: 304-357-0115.**

### **FEATURES OF THE PHONE SYSTEM**

- ❖ **To dial outside the Courthouse, dial 9 then the area code followed by the number.**
- ❖ **To dial inside the Courthouse, simply enter the last four digit extension number.**

### **AUTOMATIC CALLBACK**

**If the extension you are calling is busy, hang up, lift receiver, listen for dial tone, dial automatic callback code \* and 2, listen for confirmation tone (three tones) and hang up. Your telephone will ring when the busy extension is free.**

### **CANCEL AUTOMATIC CALLBACK**

**Lift receiver, listen for dial tone, dial cancel code # and 3 then listen for confirmation tone (three tones).**

### **TRANSFER CALLS**

**Press the switch hook or tap button, listen for dial tone, dial desired number, announce transfer, then hang up.**

### **CALL PICKUP**

To answer a call for an extension in your “call pickup group,” lift receiver, listen for dial tone, dial the call pick up code \* and 6.

### **CALL FORWARDING VARIABLE**

Lift receiver, listen for dial tone, dial call forwarded \* and 4. Listen for dial tone, dial extension number you wish to transfer your calls to, listen for the three tone confirmation. Announce your call forwarding, and then hang up.

### **TO CANCEL CALL FORWARDING**

Lift receiver, listen for dial tone, dial the cancel code # and 4, and listen for the (three tone) confirmation, then hang up.
